

# Scottish Curling Senior Women's Championship 2017-2018 Entry Form



## Outline

The Scottish Curling Senior Women's Championship is the pinnacle Seniors Women's event in Scotland with teams competing for the title and the right to represent Scotland in the World Curling Championships (Venue TBA) - 21<sup>st</sup> April to 28<sup>th</sup> April 2018.

The Championship may be in two stages:

- Qualifiers, if required.
- Championship - Lanarkshire Ice Rink (Hamilton)

## Eligibility

- Teams must be female.
- All team members must be members of the RCCC.
- All team members must be over 50 years of age by the end of the 30<sup>th</sup> day of June 2017.
- All team members must be eligible to represent Scotland subject to Rule C12 International Representation.

## Venue & Date

Qualifier - Friday 5<sup>th</sup> to Sunday 7<sup>th</sup> January 2018 if required.

Championship - Thursday 22<sup>nd</sup> to Sunday 25<sup>th</sup> February 2018 at intu Braehead (Glasgow).

## Entry Fees

£220 per team

+ an additional £120 on qualification for the Championships (if qualifiers are required).

Payment can be made by cheque, over the phone or by bank transfer (BACS). When paying by bank transfer, you must reference the team name and the competition
